## IMAGE REQUEST & ORDER FORM

- 1 Written permission is required to obtain images from The Harwood Museum of Art collections for the purpose of personal study or for reproduction, using the Harwood's Image Request Form.
- 2 The Harwood Museum does not warrant that the use of the images does not infringe upon the rights of third parties. Objects in the images may be protected by copyright and related rights that are not owned by the Harwood or whose ownership by the Harwood has not been determined. Copyright for the work may be owned by the artist, the artist's estate, or another or other rights holders. Detailed research of the work's rights history might indicate the work to be in the public domain. It is your responsibility as applicant to determine and satisfy copyright and other rights restrictions before making any use of the work beyond what is allowed by "fair use" in accordance with the United States Copyright Act and its understanding of the term. As applicant, your responsibility is to ascertain the existence of such rights as are held by living artists or by a third party or parties, pay any required fees, and secure the requisite written permission(s) to ensure that your use of the image or images does not infringe upon property rights of, or violates an agreement with, an artist or third party. In such cases, the written permission(s) must accompany the application.
- 3 Applicant agrees to hold The Harwood Museum of Art harmless from all claims and causes, all allegations, all costs, fees and expenses, awards, judgments, damages, losses and liabilities arising from or relating to any breach of this application by the applicant, representing the individual, company, or institution to whom it is issued, or by the officers, directors, shareholders, employees, agents, representatives, contractors and subcontractors, including but not limited to any claim, cause, or allegation asserted by a third party against the Harwood based entirely or in part on the applicant's exploitation of the image(s) for which permission is granted herein.
- 4 The permission granted by the Harwood solely to the applicant representing the individual, company, or institution to whom it is issued. It may not be assigned, transferred, sold, or otherwise made use of.
- 5 The permission to reproduce the image is limited by the terms and conditions set forth in this agreement. The Harwood Museum of Art retains any applicable copyright ownership and related rights. All rights not expressly granted in this agreement are reserved to The Harwood Museum of Art.
- 6 Unless indicated otherwise, permission is granted only for usage in the publication identified in the application. Subsequent publication in later editions or in derivative works requires separate permission requested by written application to the Harwood.
- 7 Except for the purpose of the image's incorporation in creation of the publication for which the application is sought, the Harwood does not otherwise grant permission to process the image in any digital format. Such permission must be sought separately in writing.
- 8 Each image that is reproduced must be reproduced in its entirety and unaltered (no cropping, no bleed off the page, not guttered across facing pages, not printed on colored stock or with colored ink, and nothing superimposed on that image. The credit line provided by the Harwood must accompany reproduction of the image separately or as part of your caption, in full and with without changes. When a detail of the image is reproduced, the word "detail" must appear in the caption containing the credit line.
- 9 Full documentation must be provided in the caption of the credit line, and the credit line, along with any notice of copyright provided to you with the image (s) must appear either on the same page as the reproduction, on the opposite page, on the reverse of the reproduction page, or in an index. The applicant may list only the artist's name, title of work, and date in one of these locations provided that full documentation, involving credit line and rights statement, appears elsewhere within the publication.
- 10 The applicant agrees to send gratis two (2) copies of the publication to Rights & Reproductions, Head of Collections, The Harwood Museum of Art.
